Posting Language

Authorize negotiation and execution of an amendment to the agreement with Central Texas Community Health Centers Inc., d/b/a CommUnityCare to provide HIV-related primary care, medications, and critical support services to people living with HIV to add a 12-month extension term ending on February 28, 2026, in an amount not to exceed \$179,310, for a revised total agreement amount not to exceed \$1,325,025. Funding: \$179,310 is available in the Austin Public Health Department's Operating Budget Special Revenue Fund.

Prior Council Action:

September 2, 2021 - Council authorized negotiation and execution of an agreement to enhance and support local HIV-related treatment services for an initial 7-month term with three 12-month extension options with Central Texas Community Health Centers Inc., d/b/a CommUnityCare in an amount not to exceed \$264,519 for the initial term and \$179,310 for each extension option, for a total agreement amount not to exceed \$1,145,715 on a 9-1 vote with Council Member Kelly voting no and Council Member Alter absent.
