Posting Language

Authorize negotiation and execution of an amendment to the agreement with AIDS Healthcare Foundation for HIV-related prevention services, to add funding in an amount not to exceed \$105,817 for the 12-month term ending on May 31, 2026, and \$105,817 each for the two remaining extension options, for a revised total agreement amount not to exceed \$1,022,079. Funding: \$105,817 is available in the Austin Public Health Department's Operating Budget Special Revenue Fund. Funding for the remaining years of the agreement is contingent upon available funding in future budgets.

Funding in the amount of \$105,817 is available in the Fiscal Year 2024-2025 Austin Public Health Department's Operating Budget Special Revenue Fund.

Prior Council Action:

July 18, 2024 - Council authorized negotiation and execution of Amendment No. 4 to the agreement with AIDS Healthcare Foundation to enhance and support local HIV-related prevention services for an initial 12-month term ending on July 31, 2025, in an amount not to exceed \$80,071, with three 12-month extension options each not to exceed \$80,071, for a total agreement amount not to exceed \$704,628, on consent on a 11-0 vote.

September 2, 2021 - Council authorized negotiation and execution of agreements to enhance and support local HIV-related prevention services for an initial 12-month term, with three 12-month extension options, with the following subrecipient-providers: Central Texas Community Health Center in an amount not to exceed \$85,209 for the initial term and each extension option, for a total agreement amount not to exceed \$340,836; and AIDS Healthcare Foundation in an amount not to exceed \$96,086 for the initial term and each extension option, for a total agreement amount not concern the extension option, for a total agreement amount not to exceed \$384,344 on a 10-0 vote with Council Member Alter absent.
