African American Resource Advisory Commission	Edit Bylaws Article 2 Purpose and Duties - add "public safety" to read as: The commission shall advise the city council on issues relating to the quality of life for the City's African American community and shall recommend programs designed to alleviate any inequities that may confront African Americans in social, economic, and vocational pursuits, including: public safety, health care; housing, including affordable housing, home ownership, and homelessness; entertainment opportunities for professionals and students; employment; and cultural venues, including museums, theaters, art galleries, and music venues.	Adding public safety to the commission’s purpose empowers it to advocate for equitable, trusted, and community centered safety policies that reduce disparities and ensure African American needs and perspectives guide Austin’s approach to safety and justice.	Staff has no concern with the proposed edit. If this proposed amendment is recommended, an ordinance would be necessary to amend City Code § 2-1-101.
	Edit Bylaws Article 1 Name - remove the word "Downtown" so the name will now read: Austin Community Court Advisory Board	The Downtown Austin Community Court Advisory Board recommends changing the name of the Board to be consistent with the new Austin Community Court departmental name.	Staff supports this update. If this proposed amendment is recommended for approval, an ordinance would be necessary to amend City Code § 2-1-131.
