- 1.0 The City hereby amends the above referenced contract to replace Section 4.4 (Aggregated Data) of the Contract as follows:
  - 4.4 Aggregated Data. Agency acknowledges that Flock will be compiling anonymized and/or aggregated data based on Agency Data input into the Services (the "Aggregated Data"). Flock shall have the right to collect and analyze Aggregated Data as described in this paragraph. Aggregated Data does not refer to or identify Agency or any individuals, or it de-identifies Agency Data and other information relating to the provision, use and performance of various aspects of the Services and related systems and technologies (including, without limitation, information concerning Agency Data and data derived therefrom). For the sake of clarity, Aggregated Data is compiled anonymous data which has been stripped of any personal identifying information. Aggregated Data has also been stripped of data reflecting the location and the date and time at which the Agency captured the data. Aggregated data will not include photographs or video that capture images of the driver or occupants of a vehicle. Aggregated Data may include photographs of license plates without any accompanying meta-data that identifies, or could reasonably be used to identify, the agency which collected the photo, where the photo was captured, and when the photo was captured. Agency hereby grants Flock a non-exclusive, worldwide, perpetual, royalty-free right and license (during and after the Service Term hereof) to use and distribute such Aggregated Data to improve and enhance the Services and for other development, diagnostic and corrective purposes, other Flock offerings, and crime prevention efforts. No rights or licenses are granted except as expressly set forth herein. Flock shall not sell Agency Data or Aggregated Data. Unless requested by Agency, Flock shall not keep or maintain Agency's Aggregated Data for longer than seven (7) days. Nothing in this paragraph shall be interpreted to permit Flock to keep or use Agency Data except as permitted by Paragraphs 4.1 and 4.2.
- 2.0 By signing this Amendment, the Contractor certifies that the Contractor and its principals are not currently suspended or debarred from doing business with the Federal Government, as indicated by the General Services Administration List of Parties Excluded from Federal Procurement and Non-Procurement Programs, the State of Texas, or the City of Austin.

ALL OTHER TERMS AND CONDITIONS REMAIN THE SAME.
