AN ORDINANCE VACATING APPROXIMATELY 0.2391 ACRES OF RIGHT-OF-WAY, BEING TWO PORTIONS OF THAT CERTAIN RIGHT-OF-WAY KNOWN AS JULIEANNA COVE, AND AUTHORIZING THE CITY MANAGER TO CONVEY THE RIGHT-OF-WAY TO PROJECT ELSIE LAND, LTD.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

- **PART 1.** Council approves the vacation of approximately 6,221 square feet (0.1428 acres) of developed right-of-way, being a portion of the street right-of-way known as "Julieanna Cove" originally dedicated to the city by the plat of the Bridgeview Business and Industrial Plaza subdivision, recorded in Volume 77, Pages 361-363 of the Plat Records of Travis County, Texas, said 0.1428-acre tract being more particularly described as "Part 1" in **Exhibit "A"**, which is attached to and incorporated as part of this ordinance, and abutting the parcels owned by Project Elsie Land, Ltd., a Texas limited partnership, and located at 71 Strandtman Cove.
- **PART 2.** Council approves the vacation of approximately 4,193 square feet (0.0963 acres) of developed right-of-way, being a portion of the street right-of-way known as "Julieanna Cove" originally dedicated to the city by the plat of the Bridgeview Business and Industrial Plaza subdivision, recorded in Volume 77, Pages 361-363 of the Plat Records of Travis County, Texas, said 0.0963-acre tract being more particularly described as "Part 2" in **Exhibit "A"**, which is attached to and incorporated as part of this ordinance, and abutting the parcels owned by Project Elsie Land, Ltd., a Texas limited partnership, and located at 21 Julieanna Cove.
- **PART 3.** A public utility easement and a drainage easement with required maintenance are reserved by the City from the vacation of this right-of-way, over the entire area of both tracts described in this ordinance.
- **PART 4.** The City Manager, or his designee, is authorized to convey the right-of-way subject to this ordinance to Project Elsie Land, Ltd. via a deed without warranty, in a form acceptable to the City Attorney or her designee, provided the deed reserves to the City the easements required to be reserved by this ordinance.
- **PART 5.** Project Elsie Land, Ltd. has posted funds with the City in the amount of \$106,233, which is the appraised fair market value of the interests in the land being vacated, and these funds will be deposited upon the City's conveyance of the right-of-way to Project Elsie Land, Ltd.
