## Posting Language

Authorize negotiation and execution of an amendment to the agreement with Asian American Resource Center, Inc. d/b/a Austin Asian Community Health Initiative for the Community Health Navigator Program, to provide community health system navigation services for members of linguistically isolated groups, to add one 12-month extension option for the term ending on September 30, 2026, in an amount not to exceed \$587,305 for a revised total agreement amount not to exceed \$4,959,215. Funding: \$587,305 is available in the Austin Public Health Department's Operating Budget.

## Prior Council Action:

November 21, 2024 - Council authorized negotiation and execution of an amendment to the agreement with Asian American Resource Center, Inc. d/b/a Austin Asian Community Health Initiative for the Community Health Navigator program to provide community health system advocacy, education, interpretation, translation, and referral services for members of linguistically isolated Asian American immigrant groups. to add funding in an amount not to exceed \$268,000, for a revised total agreement amount not to exceed \$4,371,910 on an 11-0 vote.

September 12, 2024 - Council authorized negotiation and execution of Amendment No. 12 to the agreement with Asian American Resource Center, Inc., d/b/a Asian American Community Health Initiative, for the Community Health Navigator program to add a 12-month extension option ending on September 30, 2025 and add funding in an amount not to exceed \$587,305, for a revised total agreement amount not to exceed \$4,103,910 on an 11-0 vote.

August 31, 2023 - Council authorized negotiation and execution of Amendment No. 11 to the agreement with Asian American Resource Center, Inc. d/b/a Asian American Community Health Initiative, for the Community Health Navigator program to add one 12-month extension option beginning on October 1, 2023, in an amount not to exceed \$587,305, for a revised total agreement not to exceed amount of \$3,516,605 on an 11-0 vote.
