WHEREAS, the City of Austin and Flex Realty, L.P., a Texas limited partnership, entered into that certain restrictive covenant, consisting of a 15.025 acre tract of land generally identified in the map attached as **Exhibit "A"**; and,

WHEREAS, the Property is more particularly described in the Restrictive Covenant dated March 16, 2006 and recorded in the Official Public Records of Travis County, Texas, on November 6, 2006, in Document No. 2006215145, (the "Restrictive Covenant"), as part of City of Austin Zoning Case No. C14-05-0151; and,


