## ORDINANCE NO.

AN ORDINANCE ADOPTING THE SECOND AMENDMENT TO THE AGREEMENT CONCERNING THE CREATION AND OPERATION OF SUNFIELD MUNICIPAL UTILITY DISTRICTS NOS. 1, 2, 3, AND 4 RELATING TO THE FOLLOWING FOR THE OPERATION OF SUNFIELD MUNICIPAL UTILITY DISTRICT NO. 2: BOND REIMBURSEMENT FOR WATER AND WASTEWATER PROJECTS; BOND ISSUANCE AND REIMBURSEMENT FOR ROAD PROJECTS; COST PARTICIPATION FOR A WATER RESERVOIR; UPDATES TO THE WATER SERVICE PLAN; AND A NON-SUBSTANTIVE CHANGE TO UPDATE THE LOCATION OF THE AFFORDABLE HOUSING AGREEMENT.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

## **PART 1.** The Council finds that:

- (A) Sunfield Municipal Utility Districts (MUDs or Districts) Nos. 1, 2, 3, and 4 are conservation and reclamation districts, and governmental agencies of the State of Texas created under Article XVI, Sec. 59 of the Texas Constitution by an order of the Texas Commission on Environmental Quality (formerly Texas Water Commission). The Districts operate under Chapter 54 and 49 of the Texas Water Code.
- (B) The City granted its consent to the creation of the Districts in 2005. The City, the Districts, and 2428 Partners, LLC, a Texas limited liability company, original developer and landowner of the Districts, entered into an "Agreement Concerning Creation and Operation of Winfield Municipal Utility Districts 1, 2, 3, and 4 " ("Consent Agreement"), which sets forth terms and conditions for creation an operation of the Districts. The names of Winfield MUDs Nos. 1, 2, 3, and 4 were later changed to Sunfield MUDs Nos. 1, 2, 3, and 4, respectively.
- (C) The City adopted the first amendment to the Agreement Concerning Creation and Operation of Winfield k/n/a Sunfield Municipal Utility Districts Nos. 1, 2, 3, and 4 in 2015. The City, the Districts, and 2428 Partners, LLC, a Texas limited liability company and A&M Option 541, LLC, a Texas limited liability company and successors in interest to the original developer and landowner of the Districts, entered into the "First Amendment to Agreement Concerning Creation and Operation of Winfield Municipal Utility Districts 1, 2, 3, and 4."
