

**M/WBE Summary**

Public notice was given for this Request for Qualifications CLMP364 2024 Construction Inspection Rotation List, through the City’s Financial Services website, Austin Finance Online. Ten firms submitted qualifications statements and responses were opened on January 25, 2024. Of the ten submittals received, one submittal was from an MBE/WBE certified firm.

Participation goals stated in the solicitation were 1.96% African American; 5.08% Hispanic; 3.46% Native/Asian American; 2.86% WBE. The recommended firms provided an MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.
