

### **MBE/WBE Summary**

Public notice was given for this solicitation CLMC1114, for the Little Walnut Creek - Jamestown Tributary Erosion and Drainage Improvements, through the City's Financial Services website. Four bids were received and opened on May 22, 2025. Of the four bids received, none of the firms submitting were MBE/WBE certified. Cedar Hills Construction LLC submitted the lowest responsive bid:
