Posting Language

Authorize negotiation and execution of a contract for stop-loss medical coverage for eligible City employees, dependents, affiliated employers, retirees, and Consolidated Omnibus Budget Reconciliation Act of 1985 (also known as COBRA) participants for the Human Resources Department with Health Care Service Corporation/Blue Cross Blue Shield of Texas, for an initial term of one year with four one-year extension options, for a total contract amount not to exceed \$90,020,000. Funding: \$5,209,000 is available in the Fiscal Year 2024-2025 Operating Budget of the Human Resources Department. Funding for the remaining contract term is contingent upon available funding in future budgets.

The contract is for the administration of the City's stop-loss medical coverage for eligible City employees, dependents, affiliated employers, retirees, and Consolidated Omnibus Budget Reconciliation Act of 1985 (also known as COBRA) participants. Stop-loss insurance coverage protects the City from any catastrophic claim that a covered person may incur over \$750,000.

This contract replaces the current contract expiring December 31, 2024. Requested authorization is determined based on the estimated participants on the City's health plan. The recommended contractor is the current provider of this service.

An evaluation team with expertise in this area evaluated the offers and scored Health Care Service Corporation / Blue Cross Blue Shield of Texas as the best to provide these services based on price, small business preference, local business preference, general company information, features, and claims administration.
