Timeline



- On **May 19, 2026**, staff provided the following recommendations:
 - To hold a 2028 Bond Election and,
 - To consider interim funding as part of the FY2027 Budget Process for several bond proposition categories.
- On **May 28, 2026**, through Resolution No. 20260528-097, City Council directed staff to provide supplemental information on proposed bond project proposals.
- On **July 17, 2026**, staff responded to Resolution No. 20260528-097 by submitting a Memo to the Mayor and Council (MMAC) with supplemental information on proposed bond project proposals.
- On **July 28, 2026**, staff received guidance through the Council Message Board to prepare a bond package for discussion at the August 4, 2026, Budget Council meeting with the following considerations:
 - To base a bond package with the \$390 Million scenario outlined on the July 17, 2026, MMAC for the potential 2026 Bond Program,
 - Include Parks and Recreation and Libraries propositions,
 - Reduce funding for the Parkland Acquisition category,
 - Remove the Homeless Resource Center and Shelter project, and
 - Active Transportation and Animal Services investments to be consider through other sources.

Tax Impact



- For every \$100 million in debt issued, the current estimated annual tax impact to a typical homeowner (non-senior homestead) would be \$14.10. Therefore, a \$280 million bond program would have an annual tax impact of \$39.48.

Next Steps



- **August 6, 2026** – City Council to consider the approval of an ordinance ordering a General Obligation Bond Election to be held on November 3, 2026.
