DBE Summary

The participation goal for Design Services stated in the solicitation was 4.34% DBE. (Prior to Construction, a separate DBE participation goal will be determined for Construction Services.) The recommended firm and alternate firm both provided DBE Compliance Plans that met the goal of the solicitation and were approved by the City.

Public notice was given for this solicitation CLMA057, AEDP Integrated Baggage Handling System – Design Build, through the City's Vendor Connection web portal. Three firms submitted qualifications statements and submittals were opened on April 24, 2025. Of the three submittals received, none of the firms submitting were certified DBE. Of the three firms evaluated, Beumer Corporation was determined to be the best value of the three proposals received:
