## Posting Language

Authorize negotiation and execution of a contract for web redesign of the City of Austin's austintexas.gov web site for Communications and Technology Management with TW Lrw Holdings, LLC d/b/a Material Holdings, LLC, for an initial term of three years with up to three one-year extension options, for a total contract amount not to exceed \$5,550,000. Funding: \$1,746,478 is available in the Fiscal Year 2024-2025 Operating Budget of Communications and Technology Management. Funding for the remaining contract term is contingent upon available funding in future budgets.

### Fiscal Note

Funding in the amount of \$1,746,478 is available in the Fiscal Year 2024-2025 Operating Budget of Communications and Technology Management.

Funding for the remaining contract term is contingent upon available funding in future budgets.

### Purchasing Language:

The Financial Services Department issued a Request for Proposals solicitation RFP 5600 PLS3006 for these services. The solicitation was issued on August 14, 2023, and closed on October 12, 2023. Of the fourteen offers received, the recommended contractor submitted the best evaluated responsive offer. An evaluation team with expertise in this area evaluated the offers and scored TW Lrw Holdings, LLC d/b/a Material Holdings, LLC, as the best to provide these services based on project concept and solution, demonstrated applicable experience and personnel qualifications, pricing, local business presence, and service-disabled veteran business enterprise.

A delay in contract approval would impact the City's ability to deliver much needed improvements to the City's website.
