Posting Language

Authorize negotiation and execution of an amendment to the agreement with AIDS Services Austin d/b/a Vivent Health, Inc. to provide housing services for people living with HIV to add one-time funding to the 12-month term ending on September 30, 2025, in an amount not to exceed \$153,977, for a revised total agreement amount not to exceed \$4,772,858. Funding: \$153,977 is available in the Fiscal Year 2024-2025 Austin Public Health Department Special Revenue Budget. Funding for remaining years of the agreement is contingent upon available funding in future budgets.

Funding in the amount of \$153,977 is available in the Fiscal Year 2024-2025 Austin Public Health Department Special Revenue Budget. Funding for remaining years of the agreement is contingent upon available funding in future budgets.

Prior Council Action:

January 18, 2024 -Council authorized the negotiation and execution of amendment No. 1 to the agreement with AIDS Services Austin doing business as Vivent Health to add one-time funding to the 12-month term beginning October 1, 2023, in an amount not to exceed \$118,881 for a revised total agreement amount not to exceed \$4,618,881 on an 11-0 vote.

December 8, 2022 - Council authorized the negotiation and execution of agreements with four social service agencies to provide HIV-related housing services for an initial 12-month term beginning October 1, 2022, in a combined amount not to exceed \$2,287,955, each with four 12-month extension options in a combined amount not to exceed \$11,439,775, for a total agreement amount not to exceed \$13,727,730 divided among the agencies. The motion authorizing negotiation and execution of agreements with four social service agencies was approved on an 11-0 vote.
