

ORDINANCE NO. _____

AN ORDINANCE AMENDING ORDINANCE NO. 040401-Z-2, WHICH ADOPTED THE CRESTVIEW/WOOTEN COMBINED NEIGHBORHOOD PLAN AS AN ELEMENT OF THE IMAGINE AUSTIN COMPREHENSIVE PLAN, TO REMOVE THE LAND USE DESIGNATION ON THE FUTURE LAND USE MAP FOR APPROXIMATELY 14 ACRES OF LAND ON PROPERTY GENERALLY LOCATED NORTH OF MORROW STREET, SOUTH OF WEST ANDERSON LANE, WEST OF NORTH LAMAR BOULEVARD, AND EAST OF GAULT STREET.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Ordinance No. 040401-Z-2 adopted the Crestview/Wooten Combined Neighborhood Plan as an element of the Imagine Austin Comprehensive Plan.

PART 2. Ordinance No. 040401-Z-2 is amended to remove the land use designation for approximately 14 acres of property generally located north of Morrow Street, south of West Anderson Lane, west of North Lamar Boulevard, and east of Gault Street as identified on **Exhibit “A”** incorporated in this ordinance and as shown in **Exhibit “B”** incorporated in this ordinance and described in File NPA-2025-0017.02 at the Planning Department.

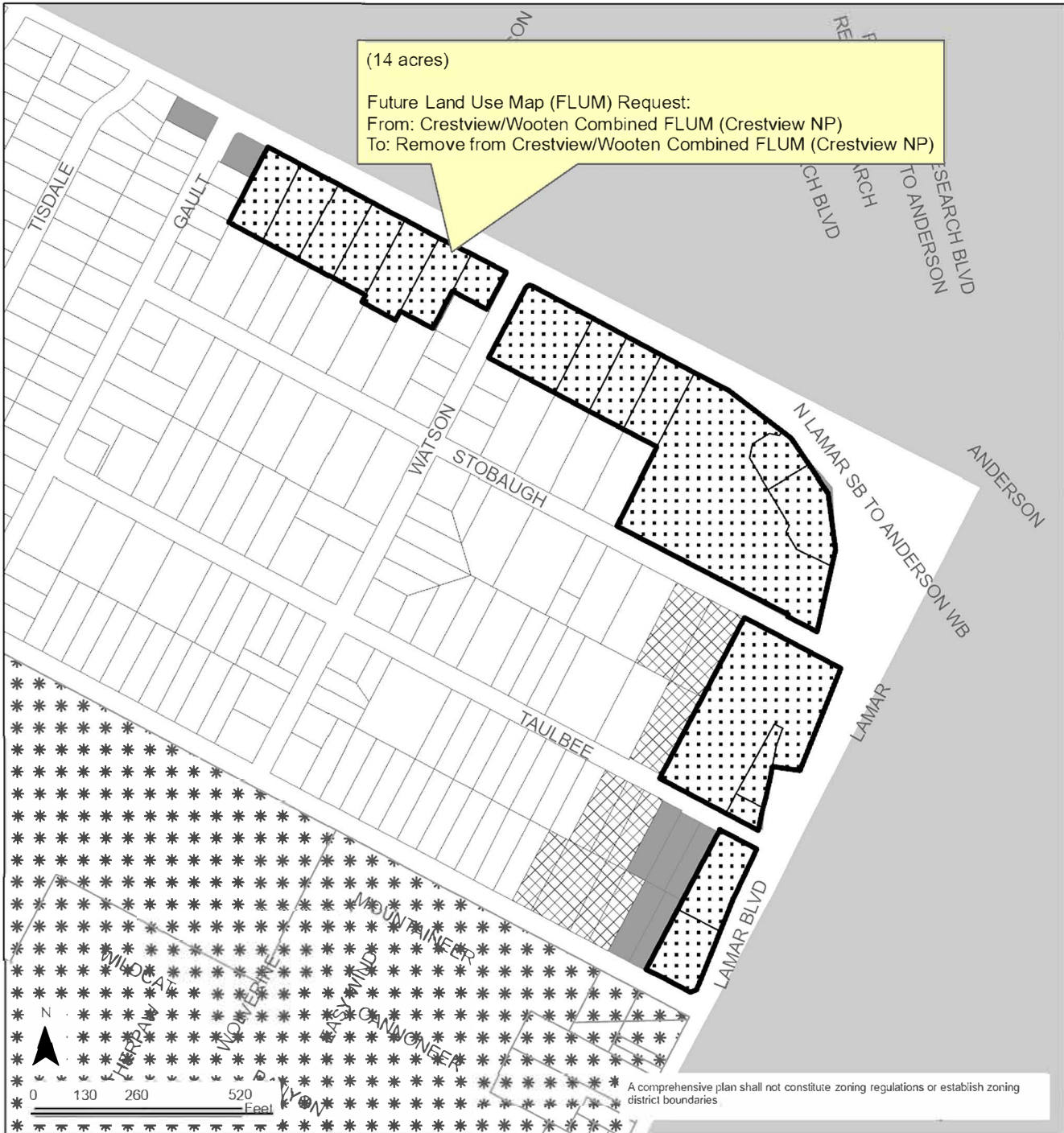
