Posting Language

Authorize negotiation and execution of an amendment to the agreement with Project Transitions, Inc. to provide housing services for people living with HIV for a 12-month term ending on September 30, 2025, in order to add one-time funding in an amount not to exceed \$1,405,303, for a revised total agreement amount not to exceed \$6,000,000. Funding: \$1,405,303 is available in the Fiscal Year 2024-2025 Austin Public Health Department Operating Budget. Funding for the remaining years of the agreement is contingent upon available funding in future budgets.

Fiscal Note

Funding in the amount of \$1,405,303 is available in the Fiscal Year 2024-2025 Austin Public Health Department Operating Budget. Funding for the remaining years of the agreement is contingent upon available funding in future budgets.

Prior Council Action:

August 29, 2024 - Council authorized the negotiation and execution of Amendment No. 2 to the agreement with Project Transitions for HOPWA to provide housing services for people living with HIV in order to add funding in an amount not to exceed \$158,508 to the term October 1, 2023-September 30, 2024, for a revised total agreement amount not to exceed \$6,000,000 on a 10-0 vote with Council Member Harper-Madison absent.

December 8, 2022 - Council authorized the negotiation and execution of agreements with four social service agencies to provide HIV-related housing services for an initial 12-month term beginning October 1, 2022, in a combined amount not to exceed \$2,287,955, each with four 12-month extension options in a combined amount not to exceed \$11,439,775, for a total agreement amount not to exceed \$13,727,730 divided among the agencies. The motion authorizing negotiation and execution of agreements with four social service agencies was approved on an 11-0 vote.
