

### **M/WBE Summary**

Public notice was given for this solicitation, CLMC1110 for the Hampton Branch at Oak Hill Parking Lot project, through the City's website. Three bids were received and opened on May 8, 2025. Of the three bids received, none of the firms submitting were certified MBE/WBE. Dalrymple Gravel and Contracting Company, Inc., submitted the lowest responsive bid:
