Posting Language

Authorize negotiation and execution of an amendment to the agreement with Jail to Jobs d/b/a Nineveh Ministries to provide the ATX Community Violence Intervention program to add one-time funding in an amount not to exceed \$200,000 for the 12-month term ending on September 30, 2025, for a revised total agreement amount not to exceed \$9,002,000. Funding: \$200,000 is available in the Fiscal Year 2024-2025 Budget Stabilization Reserve Fund.

Fiscal Note

Funding in the amount of \$200,000 is available in the Fiscal Year 2024-2025 Budget Stabilization Reserve Fund. Funding for the remaining terms is contingent upon available funding in future budgets.

Prior Council Action:

August 29, 2024 - Council authorized the negotiation and execution of Amendment No. 2 to the agreement with Jail to Jobs d/b/a Nineveh Ministries for the provision of the ATX Community Violence Intervention program, to add five 12-month extension options each in an amount not to exceed \$1,300,000, for a revised total agreement amount not to exceed \$8,802,000, on a 10-0 vote.

September 21, 2023 - Council authorized the negotiation and execution of Amendment No. 1 to the agreement with Jail to Jobs d/b/a Nineveh Ministries to provide community violence intervention services to individuals at highest risk of community violence, to add one 12-month extension beginning October 1, 2023, in an amount not to exceed \$1,502,000, for a revised total agreement amount not to exceed \$2,302,000, in an 11-0 vote.

July 28, 2022 - Council authorized negotiation and execution of an agreement with Jail to Jobs to provide community violence intervention services to at-risk individuals for a thirteen-month term beginning September 1, 2022, through September 30, 2023, in an amount not to exceed \$800,000, on a 10-0 vote.

This action will authorize negotiation and execution of Amendment No. 3 to the agreement with Jail to Jobs d/b/a Nineveh Ministries for the ATX Community Violence Intervention program, which is a collaboration between Jail to Jobs d/b/a Nineveh Ministries and Life Anew, designed to provide services to individuals who are at the highest risk of being impacted by community violence in crime hotspot locations. ATX Community Violence Intervention utilizes street outreach, conflict mediation, wraparound services, and community engagement to provide much needed support and services to individuals and neighborhoods to reduce acts of violence, enhance community cohesion, actualize peace, the agreement was renewed from 2023 to 2025,
