



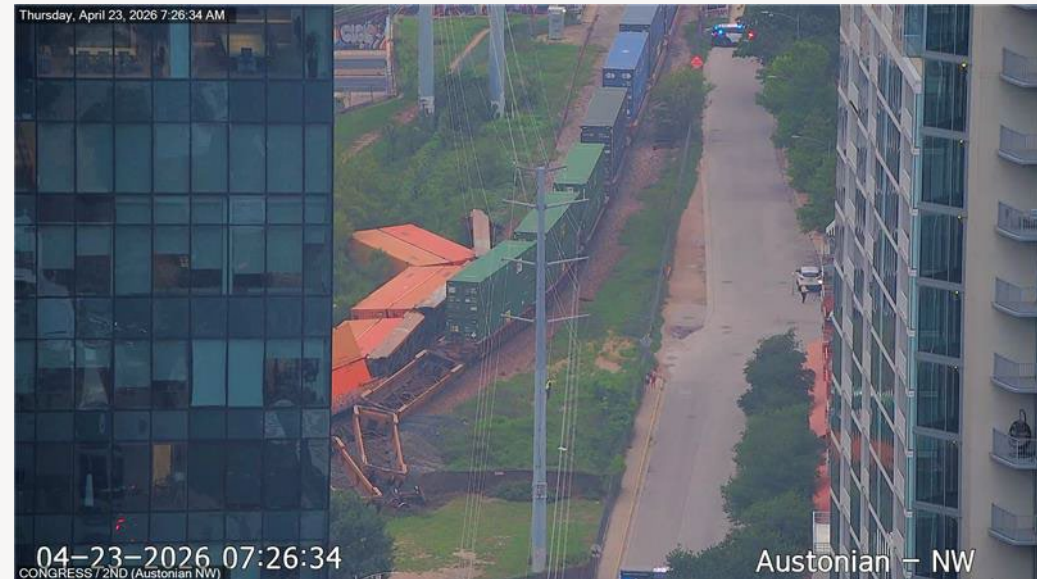
Union Pacific Train Derailment

Austin Emergency Management | June 1, 2026

Incident Summary



- During the morning of April 23, 7 cars (out of 230) derailed near West Third and Bowie streets in the Seaholm District.
- Cargo: Mixed Commodities: Medical Supplies,
- No Hazardous Materials; No Injuries
- 4am April 24: Clean-up efforts concluded with trains moving over the rail line. Cause still under investigation
- Agencies Involved:
 - Union Pacific
 - Austin Fire Department
 - Austin Emergency Management
 - Austin Transportation / Public Works
 - MMC and ROW Crews
 - Austin Police Department
 - APD Commercial Vehicle Enforcement
 - TxDOT, DPS, TDEM

Hazard Mitigation Planning

The Hazard Mitigation Action Plan (HMAP) is updated every five years to identify and assess the potential impacts of natural and human-caused hazards that threaten Austin. Hazards are identified through a review of historical records, national data sources, existing plans and reports, and collaboration with local, regional, and national experts. The purpose of the Plan is to minimize or eliminate the long-term risk to human life and property from known hazards that impact the area, such as severe weather, floods, or wildfires, through effective mitigation.

The Austin/Travis County Community Wildfire Protection Plan (CWPP) works to develop a regional strategy, aligned with national best practices, to increase wildfire preparedness. This non-regulatory document accomplishes this by restoring and maintaining landscapes, creating and supporting FACs, and implementing a risk-based management response to wildfires. The CWPP, included below, is the primary tool that communities and stakeholders should use to prepare for wildfire. It contains all of the scientific data in one place and offers a plan that communities can customize to their area's specific needs.
