

ORDINANCE NO.

AN ORDINANCE AMENDING ORDINANCE NO. 20100624-110, WHICH ADOPTED THE NORTH LAMAR COMBINED NEIGHBORHOOD PLAN AS AN ELEMENT OF THE IMAGINE AUSTIN COMPREHENSIVE PLAN, TO REMOVE THE LAND USE DESIGNATION ON THE FUTURE LAND USE MAP FOR APPROXIMATELY 125 ACRES OF LAND ON PROPERTY GENERALLY LOCATED NORTH OF US HIGHWAY 183/RESEARCH BOULEVARD, SOUTH OF BEAVER STREET, WEST OF GEORGIAN DRIVE, AND EAST OF NORTH LAMAR BOULEVARD.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Ordinance No. 20100624-110 adopted the North Lamar Combined Neighborhood Plan as an element of the Imagine Austin Comprehensive Plan.

PART 2. Ordinance No. 20100624-110 is amended to remove the land use designation for approximately 125 acres of property generally located north of US Highway 183/Research Boulevard, south of Beaver Street, west of Georgian Drive, and east of North Lamar Boulevard as identified on **Exhibit “A”** incorporated in this ordinance and as shown in **Exhibit “B”** incorporated in this ordinance and described in File NPA-2025-0026.01 at the Planning Department.


