Serves as a Co-Co-Principal Investigator for the Center for Disease Control, Center for Forecasting, and Outbreak Analytics Pandemic Preparedness grant. Is a national leader in efficacy strategies and quality control process plans for change management and innovation, resulting in improved access to quality health care for the uninsured, underinsured, and indigent members of the community and increased COVID-19 pandemic testing and vaccine distribution. Expertise in operations management, fundraising, and developing policy for both the private and public sectors to improve organizational productivity through analysis, budgeting, and the development of collaborative partnerships that expand healthcare delivery systems and increase resources toward community impact. Established as a national medical executive for policy and delivery systems and resources that effectively mitigated the COVID-19 pandemic and MPOX Outbreak response testing and vaccination distribution and successfully identified and implemented rules, guidance, and mitigation strategies to decrease community transmission. Provides strategic oversight of APH clinical operations, ensuring high-quality services through the development and annual review of SDOs for clinical operations and public health nursing activities. Establish strategic linkages with the pharmacy, stakeholders in partner organizations, city, and county government, FQHC, and social support resources to improve and expand the scope of services available to APH patients. Design and implement business strategies to realize revenue potential. A leading expert on Monoclonal Antibody Therapy and collaborates with the White House Preparedness Office and BCFS Medical Commander. Presentation to numerous elected bodies, public forums, and professional organizations, including the NACCHO Disease Forecasting and Outbreak Analysis Community of Practice Group and the UT Health Communications Leadership Institute, "Complex Public Health Communications: Using Models for Real World Public Health Decisions. Spearheaded an Austin-Travis County Collaborative to establish county-wide healthcare and social services data sharing to improve patient access to care, healthcare delivery, and costs. Convened substance use stakeholders and elected officials to respond to increased opioid deaths in Austin-Travis County and obtained almost ten thousand doses of naloxone for distribution to local harm reduction providers. Convened the Children's Mental Health Crisis Workgroup to design and align messaging across the community to empower parents, caregivers, and educators to recognize and assist children and youth with mental health issues post-pandemic in Austin-Travis County. A co-investigator/member of a trans-disciplinary team from seven universities, federal, state, and local jurisdictions that represent over 11% of the US population working to prepare for future pandemics. This effort, funded by the CDC Center for Forecasting and Outbreak Analytics grant awarded to the University of Texas will be used by APH to collaborate in the design of a systems engineering approach to assessing needs, prioritizing, designing, building, testing, and deploying proven analytical tools. Convened the Austin-Travis County Healthcare Collaborative to establish a countywide Care Coordination/Data Sharing platform to improve health outcomes

for all in the jurisdiction. Established an APH Climate Health Committee to address the effects of Climate Change across the department.

Bastrop County Health Authority, 2007 – 2021

Lead physician and medical executive for Bastrop's COVID-19 pandemic response and vaccine distribution and served as a collaborative partner with elected officials, State of Texas Public Health officials, schools, nursing homes, businesses, and residents. As a gubernatorial appointee for one of the fastest-growing counties in Texas, I managed a dynamic healthcare system establishing, maintaining, and enforcing jurisdictional quarantine orders; Advising local stakeholders such as independent school districts, long-term care facilities, and businesses in quarantine inspections, disease prevention and suppression efforts, birth and death statistics, and general sanitation issues within their jurisdiction; Reporting the presence of reportable diseases to local and state authorities; Aiding local jurisdictions and stakeholders in carrying out public health required rules, ordinances, sanitation laws, quarantine rules, and required reporting of any vital statistics collected.
