1. Approve the minutes of the Austin City Council work session of January 20, 2026, and regular meeting of January 22, 2026.

**Arts, Culture, Music, and Entertainment**

2. Approve an ordinance amending the Fiscal Year 2025-2026 Austin Arts, Culture, Music, and Entertainment Operating Budget (Ordinance No. 20250813-005) to increase revenue and appropriations by \$510,000 for operations at the Millennium Youth Entertainment Complex. Funding: \$510,000 is projected to be available from revenue collected at the Millennium Youth Entertainment Complex.

**Financial Services- Contracts**

3. Authorize a contract for the rental of a mobile security trailer and monitoring services for various parkland areas for Austin Parks and Recreation with LiveView Technologies d/b/a LVT, for an initial term of three years with up to two one-year extension options in an amount not to exceed \$2,000,000. Aly Tharp - The Wastewater Pipeline easement through Festival Beach Food Forest (FBFF) approved by Austin Parks & Recreation (APR) Board in Nov. 2024, & City Council in January 2025, did not meet Chapter 26 standards for "all reasonable planning to minimize harm to the land" and violates the partnership contract between APR & Fruitful Commons (FBFF fiscal sponsor) due to failure to provide advance notice about impacts to the food forest. FBFF stakeholders were never informed or included in the process, and were not notified in any way whatsoever until an email from TxDOT on January 6, 2026, expecting that we relocate trees and plants for trenching to begin "mid-January". TxDOT is required to host quarterly meetings with FBFF as a documented impacted party of the I-35 expansion project section at town lake, and never brought this up in any of these meetings. This is egregious, and we seek council's support to mitigate harm and the unnecessary loss of city investments in the food forest, a unique and beloved city park.
