

**M/WBE Summary**

Public notice was given for this solicitation, CLMC1094 for the Sinclair Ave Water and Wastewater Pipeline Renewal project, through the City’s Financial Services website, Austin Finance Online. Four bids were received and opened on January 23, 2024. Of the four of bids received two bids were from MBE/WBE certified firms. Facilities Rehabilitation, Inc submitted the lowest responsive bid:
