

**M/WBE Summary**

Public notice was given for this solicitation CLMC1070 2025 Miscellaneous Streets Overlay IDIQ, through the City's Financial Services website, Austin Finance Online. Three bids were received and opened on November 7, 2024. Of the three bids received none of the firms submitting were certified MBE/WBE.
