

### **M/WBE Summary**

Public notice was given for this solicitation, CLMC1112 for the Glenn Lane / Slayton Drive Storm Drain Improvements project, through the City's Financial Services website. Four bids were received and opened on May 8, 2025. Of the four bids received, two bids were from MBE/WBE certified firms. Facilities Rehabilitation Inc. submitted the lowest responsive bid:
