Affordability Impact Statements: Rule Changes

Existing

Not all departments are conducting an AIS when they make a rule change, as required by the ordinance.

When rule changes are considered, there is no public engagement.

When rule changes are made, there is rarely any public notice.

Proposed

Require all departments to perform an AIS when proposing a rule change affecting affordability.

Require all departments to conduct public engagement when proposing a rule change affecting affordability.

Develop a standard procedure for notifying stakeholders when a rule change is issued.





Affordability Impact Statements: Stakeholder Engagement

Existing

Not all departments are preparing an affordability impact statement before conducting stakeholder engagement, so there is no opportunity for public input or to revise the AIS based on stakeholder feedback.

Proposed

Enforce the existing ordinance to require an affordability impact statement to be performed prior to public engagement so the public has an opportunity to provide feedback as intended.





Affordability Impact Statements: Budgets & Amendments

Existing

Many development fees exist within the city budget and affordability impact statements are not be conducted for these items when considered by Council.

Proposed

Enforce the ordinance to require an affordability impact statement to be performed on budget items that affect affordability.





Affordability Impact Statements: Definition of Affordability

Existing

Current process only looks at impacts to construction costs and ignores other cost of living issues associated with affordability such as mobility options and food access.

Proposed

Better define "affordability impact" in the ordinance so an AIS is not limited only to the evaluation of development costs.





Affordability Impact Statements: Prioritize AIS's

Existing

Many ordinances have been passed by Council over the last couple of years intending to lower housing costs, but they have had limited evaluation of their impact on affordability using the current process.

Proposed

Utilize a more robust and holistic tool for evaluating the impact to affordability
