ORDINANCE NO.

AN ORDINANCE ESTABLISHING CLASSIFICATIONS AND POSITIONS IN THE CLASSIFIED SERVICE OF THE AUSTIN FIRE DEPARTMENT; CREATING CERTAIN POSITIONS; AND REPEALING ORDINANCE NO. 20250813-006 RELATING TO FIRE DEPARTMENT CLASSIFICATIONS AND POSITIONS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

- **PART 1.** The Council makes the following findings:
 - (A) The City adopted Texas Local Government Code Chapter 143 (*Municipal Civil Service*), which applies to members of the classified service in the Austin Fire Department.
 - (B) Chapter 143 (*Municipal Civil Service*) provides that the City Council shall establish the classifications for the Fire Department and the number of positions in each classification.
 - (C) The Fire Department recommends the creation of certain classified positions to improve delivery of fire services and to increase efficiency.
- **PART 2.** The civil service classifications of the Fire Department and the number of positions in each classification are established as follows:
 - (A) Assistant Chief <u>5</u>
 - (B) Division Chief $\underline{8}$
 - (C) Battalion Chief <u>37</u>
 - (D) Captain <u>73</u>
 - (E) Lieutenant $\underline{237}$
 - (F) Fire Specialist $\underline{232}$
 - (G) Firefighter <u>733</u>

PART 3. The number of positions in the civil service classification of Firefighter in Part 2 of this ordinance is an increase of 22 from the number in existence immediately before the effective date of this ordinance.
