Authorize an amendment to a contract for continued I Belong in Austin program administration for Austin Housing with El Buen Samaritano Episcopal Mission, to increase the amount by \$4,000,000 and to extend the term by two months for a revised total contract amount not to exceed \$21,800,000. Funding: \$4,000,000 is available in the Operating Budget of Austin Housing. Funding for the remaining contract term is contingent upon available funding in future budgets.

The contract supports the I Belong in Austin program, which provides vital financial assistance for rent, moving, storage, and relocation costs to reduce residential displacement in Austin and prevent homelessness.

The requested increase in authorization was determined based on historical spend and future anticipated use

through the contract term. The amendment is necessary to give the vendor the required operational flexibility and financial resources to complete the full scope of work originally outlined. The proposed extension and funding increase are critical to ensuring continuity of services and allowing the vendor to meet all deliverables effectively and responsibly, maximizing the impact of the program and exhausting the full value of the contract as intended.
