Posting Language

Authorize negotiation and execution of an amendment to the agreement with the University of Texas at Austin to provide community-based health prevention and education programs, to add one 12-month extension option for the term ending on September 30, 2026, in an amount not to exceed \$117,643, for a revised total agreement amount not to exceed \$1,226,934. Funding: \$117,643 is available in the Austin Public Health Department's Operating Budget.

Prior Council Action:

August 29, 2024 - Council authorized negotiation and execution of an amendment to the agreement with The University of Texas at Austin to provide community-based health prevention and education programs, to add one 12-month extension option for the period ending on September 30, 2025, in an amount not to exceed \$117,643, for a revised total agreement amount not to exceed \$1,109,291 on a 10-0 vote.

February 17, 2022 - Council authorized negotiation and execution of Amendment No. 8 to the agreement with the University of Texas at Austin to provide funding for community-based health prevention and education programs, to add two 12- month extension options each in an amount not to exceed \$117,643, for a revised total agreement amount not to exceed \$932,826 on an 11-0 vote.
