## 1 ORDINANCE NO.

APPROVE AN ORDINANCE AMENDING ORDINANCE NO. 20241119-002 ORDERING THE DECEMBER 14, 2024, RUNOFF ELECTION TO ADD THE FOLLOWING EXHIBITS: EXECUTED ENGLISH AND SPANISH VERSIONS OF THE ORDINANCE CALLING THE ELECTION (EXHIBIT B); AN EXECUTED JOINT ELECTION AGREEMENT WITH TRAVIS COUNTY ESTABLISHING THE PARTIES' ROLES AND RESPONSIBILITIES FOR THE CONDUCT OF THE RUNOFF ELECTION (EXHIBIT C); ELECTION DAY POLLING PLACES (EXHIBIT D), ELECTION DAY JUDGES (EXHIBIT E), CENTRAL COUNTING STATION STAFF (EXHIBIT F), EARLY VOTING BALLOT BOARD MEMBERS (EXHIBIT G), AND SIGNATURE VERIFICATION COMMITTEE MEMBERS (EXHIBIT H); ADOPTING THE POLLING PLACES LISTED IN EXHIBIT D AND APPOINTING THE ELECTION STAFF LISTED IN EXHIBITS E, F, G, AND H; AND DECLARING AN EMERGENCY.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

- PART 1. Ordinance No. 20241119-002 ordering the December 14, 2024, runoff election for Council Member District 7 is amended to add the following exhibits to Ordinance No. 20241119-002: executed English and Spanish versions of the ordinance calling the runoff election (Exhibit B), an executed joint election agreement with Travis County establishing the parties' roles and responsibilities for the conduct of the runoff election (Exhibit C), election day polling places (Exhibit D), election day judges (Exhibit E), central counting station staff (Exhibit F), early voting ballot board members (Exhibit G), and signature verification committee members to compare the signatures on applications for ballot by mail to the corresponding carrier envelopes (Exhibit H), all attached and incorporated herein by reference.
- **PART 2.** Council adopts the polling places listed in Exhibit D and appoints the election staff listed in Exhibits E, F, G, and H for use in the December 14, 2024, runoff election.
- **PART 3.** The Council finds that the need to adopt and publish polling locations and appoint election day judges, central counting station staff, early voting ballot
