WHEREAS, Council wishes to update the census tracts numbers of the eight geographic areas of Travis County on the CDC to reflect new census tract numbering data provided by the United States Census Bureau; and

~~**WHEREAS**, the CDC approved the following changes to the designated geographic areas for the Community Services Block Grant as recommended by Austin Public Health:~~

- ~~● North Austin: Travis County Census Tracts 18.04, 18.05, 18.06, 18.13, 18.18, 18.19, 18.20, 18.22, and 18.23;~~
- ~~● Colony Park: addition of Travis County Census Tract 22.08;~~
- ~~● South Austin: addition of Travis County Census Tracts 24.03 and 24.10;~~
- ~~● East Austin: addition of Travis County Census Tract 11.00; and~~

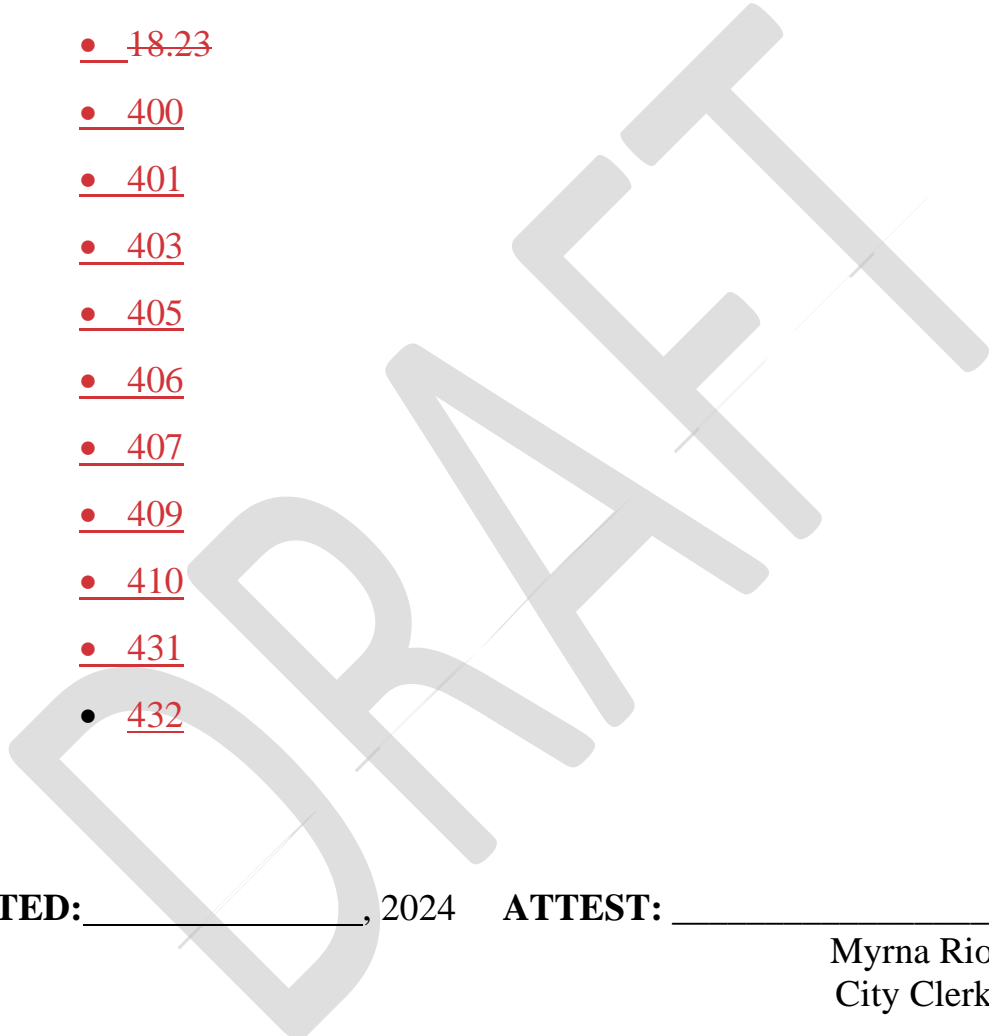
