

RESOLUTION NO.

WHEREAS, the City of Austin (City) created the Austin Housing Finance Corporation (AHFC) in accordance with Chapter 394 of the Texas Local Government Code for the public purpose and function, among others, of providing a means to finance the cost of residential developments that will provide decent, safe, and sanitary housing at affordable prices for residents of the City; and

WHEREAS, Chapter 22 of the Texas Business Organization Code (Code), authorizes the creation and organization of nonprofit corporations which may act as a duly constituted affiliate of a Texas housing finance corporation to aid and assist the housing finance corporation in the performance of one or more of its functions; and

WHEREAS, AHFC desires to further its public purposes and functions by creating an affiliated, nonprofit corporation and instrumentality named AHFC Sunset Ridge Nonprofit Corporation (Nonprofit Corporation), appointing and maintaining its Board of Directors, and otherwise exercising control over the Nonprofit Corporation, its assets, and its dissolution; and

WHEREAS, AHFC is creating the Nonprofit Corporation to act as general partner, or managing member, of the entity (Owner) that will own and operate an approximately 364 to 444-unit multifamily rental development located at 8413 Southwest Parkway, Austin, Texas 78735 (Development); and

WHEREAS, it is expected that AHFC, or an affiliated entity, will own the land and ground lease it to the Owner for the Development; and

WHEREAS, AHFC desires that the Nonprofit Corporation have and exercise all of the powers prescribed by the Code; and

25 **WHEREAS**, AHFC desires that the Nonprofit Corporation's Certificate of
26 Formation and Bylaws be in the forms, and be executed, approved, and filed in the
27 manner prescribed by this Resolution; and

28 **WHEREAS**, the AHFC Board of Directors desires to authorize and approve
29 the forms of the Certificate of Formation and Bylaws of the Nonprofit Corporation,
30 appoint the Board of Directors and President of the Nonprofit Corporation, and
31 take other action with respect to the Nonprofit Corporation; **NOW**,
32 **THEREFORE**,

33 **BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE AUSTIN**
34 **HOUSING FINANCE CORPORATION:**

35 **Section 1.** The Board of Directors finds, determines, recites, and declares
36 that it is wise, expedient, necessary, and advisable that the Nonprofit Corporation
37 be formed. The Board of Directors approves the creation and organization of the
38 Nonprofit Corporation under the provisions of the Code as a duly constituted
39 affiliate, nonprofit corporation, and instrumentality of AHFC, the City, and the
40 State of Texas. The Board of Directors authorizes the Nonprofit Corporation to aid,
41 assist, and act on its behalf and for the benefit of AHFC in the performance of its
42 functions to acquire, develop, construct, and operate affordable housing in the
43 City; to act as general partner, or managing member, of the Owner, which will own
44 and operate the Development; to promote, develop, manage, maintain, and operate
45 the Development, consistent with its role as general partner, or managing member,
46 of the Owner, as decent, safe, and sanitary housing at affordable rental rates in a
47 manner that achieves the public purpose and functions of AHFC; and to perform
48 the other purposes described in the Nonprofit Corporation's Certificate of
49 Formation.

Section 2. The Board of Directors approves the Certificate of Formation of the Nonprofit Corporation in substantially the form attached as **Exhibit A** and authorizes the incorporator of the Nonprofit Corporation to file such Certificate of Formation with the Texas Secretary of State in the manner provided by law.

Section 3. The Board of Directors appoints the initial board of directors of the Nonprofit Corporation, with their terms of office to expire at the time indicated.

Dr. Eric Anthony Johnson is appointed as the President of the Nonprofit Corporation. Other officers will be appointed as provided in the Bylaws of the Nonprofit Corporation.

Section 4. The Board of Directors approves the Bylaws of the Nonprofit Corporation in substantially the form attached as **Exhibit B** and authorizes the President of the Nonprofit Corporation to execute and file them in the corporate records in the manner provided by law.

Section 5. The Board of Directors authorizes a ground lease with the Owner.

Section 6. The Board of Directors finds, determines, recites, and declares that no note, bond, loan, debt, or other obligation of the Nonprofit Corporation is an indebtedness, liability, general or moral obligation, or pledge of the faith or credit of the State of Texas, the City, AHFC, or any other political subdivision or governmental unit, nor may any such note, bond, loan, debt, or other obligation constitute an indebtedness within the meaning of any constitutional or statutory

74 debt limitation or restriction or an agreement, obligation, or indebtedness of
75 AHFC, the City, the State of Texas within the meaning of AHFC's Articles of
76 Incorporation, the City Charter, or of any constitutional or statutory provision
77 whatsoever.

78 **Section 7.** The Board of Directors finds, determines, recites, and declares
79 that it is the purpose, intent, and desire of AHFC in approving the creation of the
80 Nonprofit Corporation and the forms of its Certificate of Formation and Bylaws,
81 that such actions and the Nonprofit Corporation hereby authorized comply with the
82 requirements of the Internal Revenue Code of 1986, as amended, and the Treasury
83 Regulations and Internal Revenue Service rulings promulgated thereunder and the
84 rulings issued pursuant thereto, such that the Nonprofit Corporation is determined
85 to be a constituted nonprofit corporation acting as an asset of AHFC pursuant to
86 the provisions of the Code and Chapter 394 of the Texas Local Government Code.

87 **Section 8.** This Resolution takes effect immediately upon its passage and
88 approval by the Board of Directors.
