

ORDINANCE NO. _____

1 **AN ORDINANCE ANNEXING, FOR FULL PURPOSES, APPROXIMATELY 9.776**
2 **ACRES OF THE ROSS ROAD ROADWAY AND ASSOCIATED RIGHT-OF-WAY**
3 **FROM THE INTERSECTION OF STATE HIGHWAY 71 EAST TO**
4 **APPROXIMATELY 381.35 FEET SOUTH OF SAINT THOMAS DRIVE AND**
5 **AUTHORIZING THE CITY MANAGER TO EXECUTE THE SERVICE PLAN**
6 **AGREEMENT WITH TRAVIS COUNTY.**

8 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

10 **PART 1.** The City Council finds that:

12 (A) Notice of the public hearings concerning the voluntary annexation of the area
13 was published in a newspaper of general circulation in the City of Austin and
14 in the area to be annexed, and on the City of Austin website.

16 (B) The public hearings were held by the City Council on February 5, 2026, and
17 February 26, 2026, at the Austin City Hall, 301 West 2nd Street, Austin,
18 Texas, and via videoconference.
19
20 (C) The public hearings were concluded after providing an opportunity for all
21 persons present to be heard with respect to the proposed annexation.
22
23 (D) The annexation, for full purposes, of the area shown on **Exhibit “A”** serves the
24 interest of the current and future residents of the City of Austin.

26 (E) All procedural requirements imposed by state law for the full purpose
27 annexation of the area shown on **Exhibit “A”** have been met.

29 **PART 2.** The present boundary limits of the City are amended to include the following
30 area, which is annexed into the City for full purposes:
31

32 Approximately 9.775 acres of the Ross Road roadway and associated right-of-way from
33 the intersection of State Highway 71 East to approximately 381.35 feet south of Saint
34 Thomas Drive, and includes 107 feet of right-of-way width, this area being shown on
35 **Exhibit “A”**.

37 **PART 3.** The annexation is limited solely to the roadway and its associated right-of-way
38 and does not include or affect any adjacent or nearby properties. Additionally, the proposed
39 annexation will not expand the City of Austin’s extraterritorial jurisdiction.

PART 4. The City Council declares that its purpose is to annex to the City of Austin each part of the area shown on **Exhibit “A”** as provided in this ordinance, whether any other part of the area is effectively annexed to the City. If this ordinance is held invalid as to part of the area annexed to the City of Austin, the invalidity does not affect the effectiveness of this ordinance as to the remainder of the area. If any area or lands shown on **Exhibit “A”** are: (1) presently part of and included within the general limits of the City of Austin; (2) presently part of and included within the limits of any other city, town or village; or (3) are not within the jurisdiction of the City of Austin to annex, then that area is excluded and excepted from the area annexed.

PART 5. The City Council authorizes the City Manager to execute the service plan agreement for the area attached as **Exhibit “B”** with Travis County, the owner of the area shown on **Exhibit “A”**. The authority granted in this part allows for non-substantive changes to **Exhibit “B”** as necessary.

PART 6. This ordinance takes effect on _____, 2026.
