**ORDER APPOINTING PRESIDING EARLY VOTING BALLOT BOARD
JUDGE AND ALTERNATE PRESIDING EARLY VOTING BALLOT
BOARD JUDGE**

Under Texas Election Code Section 32.002(a), the Travis County Commissioners Court must appoint the election judges for each regular county election precinct. Under Section 32.002(b), the election judges may be appointed to serve for a two-year term to begin on August 1, 2025 and ending on July 31, 2027.

Under Texas Election Code Section 87.002(b), the presiding judge and the alternate presiding judge are appointed in the same manner for the early voting ballot board as a presiding election judge and alternate presiding election judge, respectively.

NOW, THEREFORE:

The individuals listed in Exhibit A, which is attached to and incorporated into this order, have met the eligibility requirements prescribed by law for election judges. The Travis County Commissioners Court hereby appoints for a two-year term, from August 1, 2025 through July 31, 2027, those eligible individuals whose names are listed in Exhibit A. These individuals will serve as presiding early voting ballot board judge or as alternate presiding early voting ballot board judge, as designated in Exhibit A. The individuals appointed by this order will serve in each election ordered by the governor or by a county authority.

It is further hereby directed that this order be filed with the clerk of the Travis County Commissioners Court and that a copy be given to the custodian of the election records for the County. The County Clerk is hereby instructed to send notice of appointment to each election judge of their appointment for a two-year term beginning August 1, 2025 as stated above in accordance with Texas Election Code Section 32.009.

BE IT SO ORDERED on this 7th day of October, 2025.
