Current Funding Request: \$2,000,000 (2022 General Obligation Bonds)

<u>Development Information</u>: Funding is to be utilized for development costs for a 24-unit ownership housing development. Twenty-four (24) homes will be available for sale to households earning at or below 80 percent of the area Median Family Income. The affordability period is 99 years.
