WHEREAS, the City of Austin and Wilson Raven entered into that certain restrictive covenant regarding a 1.107 acre tract of land generally identified in the map attached as **Exhibit** "A" (the "Property"); and,

WHEREAS, the Property is more particularly described in the Restrictive Covenant dated March 26, 1979 and recorded in the Official Public Records of Travis County, Texas, on April 6, 1979, in Volume 6516, Page 2153, (the "Restrictive Covenant"), as part of City of Austin Zoning Case No. C14-79-019; and,

WHEREAS, the Restrictive Covenant imposes certain restrictions and covenants on the Property; and,

WHEREAS, the Restrictive Covenant provides that the covenant can be modified, amended, or terminated only by joint action of both (a) a majority of the members of the City Council of the City of Austin and (b) the owners of the Property at the time of such modification, amendment, or termination; and,

WHEREAS, River City Partners, LTD., a Texas limited partnership, the sole owner of the Property (the "Owner"), now desires to terminate the Restrictive Covenant; and,

WHEREAS, the City Council and the Owner agree the Restrictive Covenant should be terminated;


