

Background on the CAMPO 2050 RTP



- CAMPO is responsible for the development and maintenance of the long-range regional transportation plan (RTP) for the six-county region.
- The RTP is reviewed and updated every five years to ensure the plan's consistency with current and forecasted transportation and land use conditions and trends.
- The RTP includes goals, policies, and performance measures to guide the development of transportation in the region.
- The RTP includes a fiscally constrained project list of regionally significant transportation projects and programs that will be developed and implemented over the horizon year of the plan.
- The current RTP in effect in the region is the 2045 RTP until the 2050 RTP is adopted in May 2025.

Project Identification:


- The project listing is comprised of <u>regionally significant projects</u> that are sponsored by federal, state and local transportation agencies and governments.
- Only projects anticipating federal or state funding participation are required to be submitted and scored through the project submittal process.
- CAMPO categorizes projects to be submitted into the following categories:
 - Roadway,
 - Active Transportation,
 - Transit,
 - ITS/Operations,
 - Transportation Demand Management (TDM), and
 - Other.
- Projects may be grouped or individually listed.



- Project Identification:
- Re-Evaluate the COA 2045 RTP Project Listing
- Evaluate and consider additional projects
- Develop Draft Project Listing
 - Projects are from adopted Council plans, infrastructure reports, and needs assessments
 - Projects are individually listed or Grouped

Project Submission Process





Draft Project Listing

- 201 Roadway projects,
- 135 Active Transportation projects,
- 1 Transit project,
- 1 ITS/Operations projects,
- 1 TDM project, and
- 1 Other project



- Project Analysis and Review:
- Coordinate with Asset Owners (SMEs)
 - Update cost estimates
 - Estimate letting dates
- Determine locally funded and federally funded
- Coordinate with other agencies (TxDOT, Travis County, Williamson County, etc.)
 - Determine Sponsor or Co-Sponsor
 - Request Letters of Concurrence



- Submission:
- Memo to Mayor and Council with Draft Project Listing
- Mobility Committee Meeting July 25
- Council feedback
- Finalize Project Listing
- Submit projects by August 9



- Post-Submission: September December 2024
- CAMPO provides a summary of projects received and revenue estimation for fiscal constraint
- Negotiate any projects determined to be incomplete or rejected
- Provide updated information to CAMPO, if necessary
- CAMPO develops Draft Plan with constrained project list



- For the 2045 RTP, COA staff submitted:
 - 96 Roadway projects,
 - 28 Active Transportation projects,
 - 1 Transit project,
 - 2 ITS/Operations projects, and
 - 1 TDM project.
- Almost all projects were changed to locally funded after the constrained list was released.
- The City of Austin was also listed as a co-sponsor by other sponsoring agencies, specifically TxDOT, Capital Metro, and Travis County, to demonstrate the City's concurrence with these projects. Co-sponsorship does not commit the City to funding these projects. We expect to take a similar approach for the 2050 RTP.
