THENCE, South 03° 14' 18" East, along and with the West right-of-way line of said Old Manchaca Road and the East line of said 4.434 acre tract, a distance of 857.13 feet to a 1/2-inch iron rod found at the intersection of the West right-of-way line of said Old Manchaca Road and the North right-of-way line of Lynnbrook Drive (Variable width right-of-way) as shown on Volume 96, Page 137, M.P.R.T.C.T., and marking the Southeast corner of said 4.434 acre tract and the herein described tract;

THENCE, North 82° 43′ 04″ West, along and with the North right-of-way line of said Lynnbrook Drive and the South line of said 4.434 acre tract, at a distance of 240.17 feet passing a 1/2-inch iron pipe found for the common South corner of said 4.434 acre tract and said 4.115 acre tract, and continuing along and with the North right-of-way line of said Lynnbrook Drive and the South line of said 4.115 acre tract, a total distance of 468.67 feet to a 1/2-inch iron pipe found for the Southeast corner of a 5-foot right-of-way dedication shown on the plat of SALGADO'S ACRES, a subdivision plat recorded in Volume 96, Page 137, M.P.R.T.C.T.;

THENCE, North 87° 32' 30" East, along and with the South lines of Lots 19-24 of said SOUTHWEST GATE ADDITION and the North lines of said 4.115 acre tract and said 4.434 acre tract, at a distance of 37.63 feet passing a 1/2-inch iron pipe found for the common South corner of said Lots 19 and 20, at a distance of 118.63 feet passing a found 1/2-inch iron pipe found for the common South corner of said Lots 20 and 21, at a distance of 361.63 feet passing a 1/2-inch iron pipe found for the common South corner of said Lots 23 and 24, at a distance of 445.13 feet passing a 1/2-inch iron pipe found for the Southeast corner of said Lot 24 and being the Southwest corner of a 5-foot right-of-way dedication as shown on said plat, and continuing for a total distance of 450.16 feet to the **POINT OF BEGINNING** and containing 8.552 acres of land.
