Public notice was given for this solicitation CLMC950, Burnet Road Corridor – Bright Verde Way to Loop 1, through the City's Financial Services website, Austin Finance Online. Three bids were received and opened on November 6, 2025. Of the three bids received none of the firms submitting were certified MBE/WBE.
