3 **AN ORDINANCE AMENDING CITY CODE TO MOVE LIMITS ON SPECIAL**
4 **EVENTS AT CERTAIN PUBLIC RECREATION AREAS FROM CHAPTER 8-1**
5 **(PARKS ADMINISTRATION) TO CHAPTER 4-20 (SPECIAL EVENTS); AMEND**
6 **DEFINITIONS; UPDATE THE LIST OF SPECIAL EVENTS ON PUBLIC**
7 **RECREATION AREAS; AND ADD PROVISIONS RELATED TO NEW SPECIAL**
8 **EVENTS AT CERTAIN PUBLIC RECREATION AREAS.**

10 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

12 **PART 1.** City Code Section 4-20-1 (*Definitions*) is amended to amend the definition of
13 “City Facility” and “Legacy Event”, to add a new definition for “Public Recreation Area”,
14 and to renumber the remaining definitions.

15 (3) CITY FACILITY means city public recreation areas [~~parkland~~], buildings,
16 and all other city-owned, controlled, or maintained property that is not a
17 street, sidewalk, right-of-way, or spaces not open to the general public for
18 rental.

19 **Returns** (8) LEGACY EVENT means a special event that has been held in the City of
20 **defintion** Austin in substantially the same form for a minimum of 20 consecutive
21 **back to** years or is authorized by Subsection (E) of Section 4-20-28 (*Limits on*
22 **20 years.** *Special Events on Public Recreation Areas*).

23 (12) PUBLIC RECREATION AREA means a park, recreational facility,
24 athletic field, building, swimming pool, playground, nature preserve, trail,
25 dock, or greenbelt managed, maintained, or operated by Austin Parks and
26 Recreation or on Austin Parks and Recreation’s behalf.

28 **PART 2.** City Code Section 4-20-20 (*Permit Required; Exceptions*) is amended to amend
29 Subsection (B) to read:

30 (B) A special event permit under this chapter is not required for:

31 (1) an event, which may include food or non-alcoholic beverage service,
32 conducted entirely:

33 (a) on a public recreation area [~~city parkland~~] that uses only Austin
34 Parks and Recreation [~~Department~~] facilities, personnel and
35 equipment; or

(b) in a city auditorium or meeting room that requires only the facilities, personnel, or equipment associated with the facility; or

(2) a spontaneous event for which an attendee or event organizer cannot provide the level of advance notice required by this chapter, such as an event occasioned by recent news or current affairs, that is conducted solely on city right-of-way or parkland. A spontaneous event is subject to other law. To help ensure public safety, an organizer of a spontaneous event is not required to, but is encouraged to, notify the Austin Police Department of the date, time, place, and an estimate of the approximate number of persons who will be participating.

PART 3. City Code Chapter 4-20 (*Special Events*) is amended to add a new section 4-20-28 to read:

§ 4-20-28 LIMITS ON SPECIAL EVENTS ON PUBLIC RECREATION AREAS.

- (A) This section applies to a special event that anticipates 1,000 or more attendees and the special event includes the exclusive use of all or part of the public recreation area for the event.
- (B) For purposes of this section, special event days do not include days to set up and take down a special event.
- (C) Except as provided in Subsections (D) and (E), the Council establishes the maximum number of special event days for the following public recreation areas:
 - (1) Zilker Metropolitan Park is 24 per calendar year;
 - (2) Festival Beach at Edward Rendon Senior Metropolitan Park is 17 per calendar year; and
 - (3) Auditorium and Vic Mathias Shores at Lady Bird Lake Metropolitan Park is 17 per calendar year.
- (D) As of April 23, 2026, the reoccurring special events and days used are:
 - (1) Zilker Metropolitan Park:

73 (E) Continued Use and New Special Events.

- 74 (1) Council authorizes the continued use of the public recreation areas for the
75 number of special event days described in Subsection (C).
- 76 (2) If a reoccurring special event described in Subsection (D) does not occur in
77 substantially the same form after the effective date of this section, the city
78 manager may not allow the special event days to be used by a different
79 special event until the number of days used per calendar year is less than
80 maximum established in Subsection (C).
- 81 (3) Once the number of days used is less than the maximum established in
82 Subsection (C), the city manager may create a competitive process so that
83 new special events can use the remaining special event days.
- 84 (a) If a new special event is authorized under this subsection, the days for
85 that event count towards the maximum number of special event days
86 established in Subsection (C).
- 87 (b) The new special event qualifies as a legacy event unless the special
88 event does not occur in substantially the same form after the first year.

89 (F) In addition to the days authorized in Subsection (C), the city manager may
90 authorize multi-day non-reoccurring special events to take place at Auditorium and
91 **Allows for one-time events that are multi-day.** Vic Mathias Shores at Lady Bird Lake Metropolitan Park for a municipal purpose
92 if the total number of special event days does not exceed 25 per calendar year. In
93 evaluating a request described by this subsection, city manager must consider the
94 following factors:

- 95 (1) a scheduling conflict at the public recreation area or with adjacent
96 properties;
- 97 (2) traffic congestion;
- 98 (3) potential damage to park property or landscape;

- (4) potential threat to public health, safety or welfare;
 - (5) availability of city resources required to permit and to provide services to the special event; and
 - (6) availability of other public recreation areas for the special event.
- (G) Nothing in this section limits the City Manager's authority to establish a maximum number of special event days that may be used at other public recreation areas.
- (H) An event organizer may not transfer the special events days that apply to their special event described in Subsection (D) or in Subsection (E)(3) unless the event organizer follows the requirements adopted by administrative rule.

PART 4. City Code Section 8-1-15 (*Limits on Special Events on Public Recreation Areas*) is repealed.
