Additional Backup Information:

Austin Water treats raw lake water to produce drinking water that meets and exceeds state and federal water regulation standards. A fundamental objective of drinking water treatment is the removal of suspended solids through the coagulation process. Cationic polymer will be used daily by Austin Water to aid the coagulation treatment process, providing additional charge neutralization of suspended solids. The polymer will also enhance treatment of highly turbid raw water during flood events such that Austin Water can maintain plant production and continuously provide high quality treated water to the customers.

This is a new contract. The requested amounts were determined by departmental estimates using historical, current, and projected spending data. The recommended contractor is not the current provider of these goods.
