The Financial Services Department issued an Invitation for Bids (IFB) 1100 MMH1013 for these services. The solicitation was issued on August 15, 2022 and closed on September 22, 2022. Of the six offers received, the recommended contractor submitted the lowest responsive offer. **Council Committee, Boards and Commission Action:**

January 9, 2023 - Recommended by the Electric Utility Commission on a 7-0 vote with Commissioners Hopkins and Bowen absent and two vacancies.

**Additional Backup Information:**

The contract will provide grounds maintenance and landscaping services for Austin Energy's substations, vacant lots, and power plants. Services include commercial mowing, trimming, edging, and irrigation inspection and repair to ensure appropriate lawn care management and code compliance.

The scope of work was reviewed by staff in accordance with the Contact Labor Resolution to determine if outsourcing or hiring of staff would best meet the department's needs and comply with the Resolution. Given the need of these services being seasonal, staff determined that outsourcing the services to a contractor would be cost beneficial and meet department needs.

The recommended contractor is not the current provider for these services.
