Additional Backup Information:

The contract will provide structural drying services for the City. These services are used to clean, extract, disinfect and dry business and residential housing from water damage due to a main break or back-up from sanitary sewer overflows. This contract will also be used to provide services for upcoming planned cleaning projects within City buildings.

The requested amounts were determined by departmental estimates using historical, current, and projected spending data. Additionally, the increased amount requested encompasses unexpected natural occurrences such as flooding and freezing, price increases, and unexpected emergencies. The recommended contractor is the current provider of these services.

The contract for these services replaces a contract which expires February 16, 2023. If the City is unable to procure these services, the City will not have a reliable and continuous source for these services, which may result in higher prices and sanitary concerns.
