Authorize execution of a contract for prescription protective safety eyewear and repair services with PDS Consultants, Inc. d/b/a Korrect Optical, for a term of five years in an amount not to exceed \$500,000.

Funding in the amount of \$84,000 is available in the Fiscal Year 2022-2023 Operating Budgets of various departments. Funding for the remaining contract term is contingent upon available funding in future budgets.

The Financial Services Department issued an Invitation for Bids (IFB) 5000 MLJ1007REBID for these goods and services. The solicitation was issued on August 15, 2022 and closed on September 8, 2022. Of the two offers received, the recommended contractor submitted the lowest responsive offer.
